### FACULTY

ADRIENNE ASCH, PH.D., is the Edward and Robin Milstein Professor of Bioethics at the Wurzweiler School of Social Work and Professor of Epidemiology and Population Health at the Albert Einstein College of Medicine at Yeshiva University. She received her M.S. in Social Work and a Ph.D. in Social Psychology from Columbia University. Her work focuses on the ethical, political, psychological, and social implications of human reproduction and the family. She has authored numerous articles and book chapters. Dr. Asch has been a member of the Board of Directors of the American Society for Bioethics and Humanities and the Clinton Task Force on Health Care Reform. She is a board member of the Society of Jewish Ethics and a Fellow at The Hastings Center, and has worked with the National Human Genome Research Institute.

ALAN ASTROW, M.D., is Director of the Division of Hematology/Oncology at Maimonides Medical Center and Associate Medical Director for Hematology/Oncology at Maimonides Cancer Center. His research interests include ethics of medical decision making and chemotherapy of gynecological cancers and HIV-related malignancies. Dr Astrow studies spirituality and physician-patient communication.

**SAUL BERMAN, RABBI, J.D.,** is Director of Edah and Associate Professor of Jewish Studies at Yeshiva University and on the faculty at Columbia University School of Law. Rabbi Berman has taught at Stern College for Women, Yeshiva University, and was formerly Senior Rabbi of the Lincoln Square Synagogue in Manhattan. He is widely recognized for his inclusive approach to Jewish community and Jewish thought.

**ELLIOT DORFF, RABBI, PH.D.**, earned his Ph.D. in philosophy from Columbia University in 1971. He has directed the rabbinical school and Masters programs at the University of Judaism, where he currently is Rector and Distinguished Professor of Philosophy. He teaches a course on Jewish law at UCLA School of Law. He was awarded the Journal of Law and Religion's Lifetime Achievement Award, and he holds three honorary doctoral degrees. Rabbi Dorff is Vice-Chair of the Conservative Movement's Committee of Jewish Law and Standards and served on the editorial committee of Etz Hayim: Torah Commentary for the Conservative Movement. He is a widely published author on Jewish law and practice, and ethics.

**LESTER D. FRIEDMAN, PH.D.**, is Senior Scholar-in-Residence at Hobart and William Smith Colleges. He has taught at Syracuse University, Art Media Studies Department, and Northwestern University, Department of Radio, Television, and Film. In addition, he was a member of the Program in Humanities and Bioethics at the Feinberg School of Medicine, Northwestern University, and the Center of Bioethics and Humanities at Upstate Medical Center, Syracuse New York.

HARRY OSTRER, M.D., is Professor of Pediatrics, Pathology, and Medicine and Director of the Human Genetics Program in the Department of Pediatrics at New York University School of Medicine. He studies the genetics of Jewish populations, as well as the genetic basis of prostate cancer and genetic control of male sexual development. He has been concerned about fairness in the use of genetic information and has served on many prestigious advisory panels. Dr. Ostrer has received awards from numerous foundations and academic institutions.

ROBERT POLLACK, PH.D., is a professor at Columbia University in the Department of Biological Sciences and adjunct professor in the Department of Religion. He is also an adjunct professor of Science and Religion at Union Theological Seminary and lecturer at the Center for Psychoanalytic Training and

Research, Department of Psychiatry, College of Physicians and Surgeons, Columbia University. He holds positions on many advisory and editorial boards and has published extensively on subjects ranging from genetics to humanistic issues in clinical practice.

RAYNA RAPP, PH.D., is Professor of Anthropology at New York University. Her research interests include gender, reproduction, health and culture, and science and technology in the United States and Europe. Her book *Testing Women, Testing the Fetus: the Social Impact of Amniocentesis in America* (Routledge, 1999) won four distinguished awards. She is a founder of Women's Studies programs and journals. She has also been active in an international research group tracking the impact of new medical technologies, and two bioethics projects concerned with the re-inscription of race as a medical category through genomic research.

AVRAM REISNER, RABBI, PH.D., is the rabbi of Congregation Chevrei Tzedek in Baltimore, MD and is an Adjunct Assistant Professor at Baltimore Hebrew University. He is a member of long standing on the Conservative Movement's Committee of Jewish Law and Standards where he sits on the subcommittee on biomedical ethics. He currently serves on an Institutional Review Board for Lifebridge Health. He has just completed a two year project for the Interactivity Foundation of West Virginia, as a member of its expert panel on Anticipating Human Genetic Technology.

DAVID TEUTSCH, RABBI, PH.D., is Director of the Center for Jewish Ethics and the Louis & Myra Wiener Professor of Contemporary Jewish Civilization at the Reconstructionist Rabbinical College, where he previously served as President for nearly a decade. His most recent book is *Spiritual Community: The Power to Restore Hope, Commitment and Joy.* Editor-in-Chief for the Kol Haneshamah Reconstructionist prayer book series, he recently published the third book in *A Guide to Jewish Practice.* He has previously served as Executive Director of the Federation of Reconstructionist Congregations and Havurot (now JRF), as program director of CLAL, and as a congregational rabbi. He is the past president of the Academic Coalition for Jewish Bioethics and author of *A Guide to Jewish Practice: Bioethics.* 

HAVA TIROSH-SAMUELSON, PH.D., is Professor of History at Arizona State University in Tempe, AZ. She received her Ph.D. in Jewish Philosophy and Kabbalah from the Hebrew University of Jerusalem in 1978. She has taught at Columbia University, Emory University, and Indiana University. Her research focuses on medieval and early-modern Jewish intellectual history, feminism and Jewish philosophy, and Judaism and ecology. Most recently she is the author of Happiness in Premodern Judaism, from Hebrew Union College Press.

**PAUL ROOT WOLPE, PH.D.**, is a Senior Fellow of the Center for Bioethics at the University of Pennsylvania, where he holds appointments in the Departments of Psychiatry, Medical Ethics, and Sociology. He also serves as Senior Fellow of the Leonard Davis Institute for Health Economics and as Chief of Bioethics and Human Subjects Protections at NASA. He is President of the American Society for Bioethics and Humanities.

LAURIE ZOLOTH, PH.D., is the Director of Ethics at the Center for Genetic Medicine of the Feinberg School of Medicine at Northwestern University and Professor in the Program of Medical Humanities and Bioethics and in the Department of Religion. A member of NASA's National Advisory Council and the Executive Committee of the International Society for Stem Cell Research, she is the author of numerous publications on healthcare and social justice.
